2.2	Direct link to the section of your website where the decisions are published	A dedicated section on your website might be convenient
2.3	List of representatives	A direct link to the document or Article Nr. where the gender balanced policy/rules are outlined can raise the score
2.4	Direct link to policies / rules that outline that security measures are in place	Mandatory e-learning on data protection or a regularly organised information session of risks and best practices in relation to data protection and IT security can suffice
