ARTICLE 1. Players' Nominations

- 1.1 May not have played in WBSC Europe Competitions during at least the two last years
- 1.2 Must have played in WBSC Europe Competitions: for a minimum period of six competitive years and at least in sixty games
- 1.3 Nominations for players may only be submitted by the Member Federations and on the form provided by the WBSC Europe office.
- 1.4 Definition of "Games played in WBSC Europe Competitions": Games played in WBSC Europe Competitions are games played in WBSC Europe Championships and/or games played in WBSC Europe Cup Tournaments. In case of doubt the Hall of Fame Committee decides, whether a played game is a game played in WBSC Europe Competitions or not, and their decision is final for the purpose of this article
- 1.5 One Affiliated Federation may not nominate more than two players for any given year

ARTICLE 2. Non-players' Nominations

- 2.1 Umpires: Ten years in WBSC Europe Competitions
- 2.2 Coaches / Managers: Six years in WBSC Europe Competitions
- 2.3 Administrators / Organizers / Meritorious Service: having been active in international Softball (World or WBSC Europe level) for at least fifteen years
- 2.4 Meritorious Service includes such combinations as: Umpire, Coach, Sponsor, Organizer and Administrator
- 2.5 A nomination form will be provided by the WBSC Europe Office.
- 2.6 One Affiliated Federation may for any given year nominate only one nominee in each of the categories: Umpires, Coaches / Managers and/or Administrators / Organizers / Meritorious Service

ARTICLE 3. Selection Committee

3.1 The Selection Committee shall be comprised of four persons plus the WBSC Europe Secretary General. At least three committee members' votes are required to recommend a nominee to the Congress for election

If the committee is required to vote on a nominee from the same country as one (or more) of the committee members, then such member(s) will not participate in the voting for that nominee

- 3.2 Nominations must be submitted at least 60 days prior to the date of the Congress at which the nominations are to be considered. To be validly examined by the Selection Committee, a nomination must be made on the official form provided by the WBSC Europe office.
- 3.3 A suitable recognition Plaque and Certificate and a Life-Time-Pass to WBSC Europe events shall be presented to the Honouree by or on behalf of the WBSC Europe within six months of the election
- 3.4 The members of the Selection Committee shall be appointed by the WBSC Europe President. The Chair of this Committee shall be the WBSC Europe President.
- 3.5 The Committee shall meet immediately prior to the Congress at the venue of the Congress
- 3.6 The decisions of the Selection Committee are final and not subject to appeal.
