#### a. DISCRIMINATION (New)

Section 22 – DISCRIMINATION

Clause 22

BFA shall not allow any discrimination against Member Federations, Associations or Organizations or individuals (athletes, officials, umpires, delegates, and the like) on the grounds of race, national origin, sex, color, religion, sexual orientation, ancestry, disability, or political affiliation.

## b. DISPUTES (New)

Section 23 – DISPUTES

Clause 23.1 Disciplinary Proceedings by National Federations

23.1.1

BFA recognizes the jurisdiction and right of a National Federation and the sport to discipline or disqualify in its own territory and its own sport any person in accordance with the rules of that National Federation or sport, in accordance with the obligations of that National Federation or sport to provide a full and fair opportunity for such person to be present, to be heard, to be represented by counsel and to appeal any such decision.

#### 23.1.2

Subject to these Constitution, an applicable code and applicable law, a National Federation shall have the right to discipline or disqualify a foreign person that, in a BFA competition sanctioned by that National Federation, violates the rules of that National Federation. After a final determination is made and a decision is made to discipline or disqualify the person, the decision shall be provided to BFA and the National Federation to which the person belongs. All National Federations and BFA shall abide by the final determination (if appealed, a determination is not final unless and until affirmed on appeal). Should that foreign person contest any such decision of that National Federation, that person has the right to appeal such decision to the Court of Arbitration for Sport ("CAS") under the applicable rules of CAS. The decision of the CAS shall be final. c) BFA may discipline or disqualify any person for any offense, which is a violation of these Constitution or a Code, pursuant to Section 8 of these Articles of Association.

23.1.3

BFA may discipline or disqualify any person for any offense, which is a violation of

these Constitution or a Code, pursuant to Section 8 of these Articles of Association.

## Clause 23.2 - Dispute Resolution

23.2.1 A complaint seeking a disciplinary ruling may be brought by the Executive Board, any National Federation or any Continental Association arising out of an act or omission that involves a matter under these Constitution or a Code, or arising out of a BFA competition that is not otherwise provided for in these Constitution or a Code. All complaints shall be in writing, state the matter of concern, accompanied by any supporting documentation, and a list of witnesses or other persons having information on which the complaining party wants to rely. Resolution of that complaint is be governed by Section 8 of these Constitution.

#### 23.2.2

A complaint for dispute resolution may not be filed with WBSC unless and until all available administrative remedies provided by any other organization with authority over such complaint are exhausted.

#### 23.2.2

The sole and exclusive means for dispute resolution shall be as provided for in these Constitution

  - i. Amendment to the TQB of BFA all level Tournament Rules and Regulation

#### C11. TIE BREAKING

All ties after the preliminary round will be settled as follows (in order): The standing of the teams after the round robin shall be according to the win-loss record of all the games played. All ties after Opening Round, Super Round and Finals shall be settled in the order of the following list. That is, if criteria (1) does not break the tie, then it is no longer considered the criteria capable of breaking the tie, and the next criteria (2) will be used. This logic continues through the list, in order, until the tie is broken:

(1) The team that won the game(s) between the teams tied shall be given the higher

position.

- (2) Team's Quality Balance (TQB) and win-loss records in games between the teams tied.

  Note: If three or more teams are tied and when criterion 1 does not break a
  tie, the team with the highest TQB will be placed in the first spot. The TQB
  is calculated as follows: (runs scored / innings played at bat) (runs allowed
  /innings playing on defense). For a three-way tie and when the TQB is needed
  to break the tie, the TQB will place all three teams from highest to lowest
  placing.
- (3) The team that has the best Earned-Runs Team's Quality Balance (ER-TQB).
- (4) Highest batting average in games between the teams tied.
- (5) A coin flip.

- **Team B:** 12 runs scored in 17 offensive innings = 0.706; 7 runs allowed in 17 defensive innings = 0.412 **TQB = 0.294**
- **Team A:** 5 runs scored in 17 offensive innings = 0.294; 6 runs allowed in 17.67 defensive innings = 0.339 **TQB = -0.045**
- **Team C:** 4 runs scored in 17.67 offensive innings = 0.226; 8 runs allowed in 17 defensive innings = 0.471 TQB = -0.244

# ii. Discuss the proposition of amendment to Tournament Rules and Regulation of West Asia Cup and East Asia Cup

The qualifiers for Asian Champion in West Asian countries will depend on the round of the Senior Asian Baseball Championship that is played in East Asia and West Asia. Out of which four teams qualify for the championship. One is the event winning team, and the other is the host team. It is requested that the top two teams of the tournament qualify instead of the host team. If the qualifying round cannot be held, the teams should qualify for the Asian Baseball Championship on the basis of ranking.

must be born between XXXX/01/01 to XXXX/12/31. The age between 18-25 years old.

- B) Be a student who is currently officially registered as proceeding towards a degree or diploma at a university or similar institute whose status is recognized by the appropriate national academic authority of his country (region).
- C) Be a former student of an institution mentioned in (B) who has obtained the academic degree or diploma in the years preceding the event.

## A5. DOPING CONTROL

Preliminary phase: at least one game from each group each day with two players selected per team. The intention in the preliminary phase is to test each team at least once and preferably twice. However, such testing shall be limited to up to 2 games per day. Two players per team will be selected from all quarter final, semifinal and final games.

#### **B7. COMPETITION SYSTEM**

## 6-Team Format

## **Round-robin Competition**

1 group of 6 Teams, will play all vs. all, with top 4 teams from the group advancing to the Final. In case of a tie, see tie-breaking system.



#### **Finals**

The teams will play in the Final Round in the following manner:

- 1st and 2nd places after the First Round will play Gold medal game;
- 3rd and 4th places after the First Round will play Bronze medal game.

## **Designated Hitter**

C7.2. The designated hitter shall be accepted.

#### **Run difference Rule**

C7.6. If a team is losing by fifteen (15) or more runs after having batted at least in five (5) innings, the game is ended at that point. If a team is losing by ten (10) or more runs after having batted at least in seven (7) innings, the game is ended at that point. However, mercy rules will not apply to the Championship game while it is enforced for the bronze medal game.
